SURFACE PREPARATION:

Saw cut slot to the specified depth and width in concrete or asphalt. Move water or dust from saw cut slot with oil free compressed air.

MIXING:

Combine one part by volume of Component "A" with one part by volume of Component "B". The blend should be thoroughly mixed for at least three minutes with an EpoxySystems'-Mixing Paddle on a low speed (300 to 600 rpm) drill motor.

APPLICATION:

Apply immediately after mixing. Place wire in slot and fill with PRODUCT #960 Loop Sealant. Lower temperatures will lengthen set time.

YIELD:

One gallon of PRODUCT #960 Loop Sealant provides 231 cubic inches of liquid sealant.
